## jiayin Group Inc. Announces Cash Dividend

SHANGHAI, China, July 10, 2023 (GLOBE NEWSWIRE) --Jiayin Group Inc. (“Jiayin” or the “Company”) (NASDAQ: JFIN), a leading fintech platform in China, today announced that its board of directors approved the payment of a cash dividend of US\$0.10 per ordinary share, or US\$0.40 per American depository share (“ADS”). The holders of the Company’s ordinary shares shown on the Company’s record at the close of trading on July 28, 2023 (U.S. Eastern Daylight Time) will be entitled to these dividends. These shareholders, including Citibank, N.A., the depository of our ADS program (the “Depository”), are expected to receive the payments of dividends on or around August 2, 2023. Dividends to the Company’s ADS holders are expected to be paid through the Depository on or around August 16, 2023, and will be subject to the terms of the deposit agreement by and among the Company and the Depository, and the holders and beneficial owners of ADSs issued thereunder, including the fees and expenses payable thereunder. The aggregate amount of cash to be distributed for the dividends is expected to be approximately US\$21.5 million.
